Therefore, as an inducement to Powerstone to receive, accept and examine the Material, and in consideration of it so doing, as well as the mutual covenants herein contained, the Author hereby represents, warrants and agrees and Powerstone hereby agrees as follows:

- 1 The Material is voluntarily submitted and the Author is the present and sole owner of all right, title and interest in and to the Material with the exclusive unconditional right and authority to release the Material to Powerstone upon the terms and conditions set forth herein. No third party is entitled to any compensation as a condition of the use of the Material and the Author hereby agrees to indemnify and hold Powerstone harmless from any and all claims, expenses, losses, or liabilities that may be asserted against or incurred by Powerstone at any time in connection with the use of the Material, including without limitation, those arising from any breach or alleged breach of the warranties and covenants given by the Author herein, including reasonable legal fees and other costs incurred defending against the same.
- 2 The Author acknowledges that Powerstone receives numerous submissions of ideas, formats, stories, suggestions and screenplays, which submissions may be similar or identical to this submission and that the Author will not be entitled to any compensation because of the use by Powerstone of any such similar or identical material.
- 3 The Author further acknowledges that the presentation of the Material by Powerstone will expose the Material to others and hereby specifically releases Powerstone from any and all

liability, direct or indirect, resulting from the improper use by any other persons or entities of any similar ideas, formats, stories, suggestions and the like relating to the Material.

- 4 Powerstone agrees that it will not use the Material unless it shall first negotiate with the Author compensation for such use, but the Author agrees that the use of material containing features and elements similar to or identical with those contained in the Material shall not oblige Powerstone to negotiate with the Author nor entitle the Author to any compensation if it determines that it has an independent right to use such other material which is not derived from the Author, either because such features and elements were not new or novel, or were not originated by the Author, or because other persons have submitted or may submit material containing similar or identical features or elements which Powerstone has a right to use.

- 8 The Author hereby states that he has read and understands this Release; that no oral representations have been made to the Author; that there are no prior or contemporaneous agreements, oral or otherwise, in effect between the Author and Powerstone pertaining to said screenplay or pertaining to the submission by the Author of any ideas, formats, plots, or characters; and, that this Release states our entire understanding. The Author expressly agrees that no other obligations exist or shall exist or be deemed to exist unless and until a formal written agreement has been prepared and entered into by the Author and Powerstone.
